Forbes of Callendar Papers finding aid Part 17 – Legal papers, Callendar Estates

This collection consists of 36m of records from 1531-1974. The records have been arranged into twenty eight series (see introduction for details) and the finding aid has been separated into these series to make it easier to download from our website.

Part 17 contains legal papers relating to estate of Callendar and related lands in sheriffdoms of Stirling, Dunbarton and West Lothian, 1531 -1901. The early writs in this section were apparently productions in the case of Wilson v. Forbes. (See Nos 4018-4028.)
