### Forbes of Callendar Papers finding aid Part 19 – Earlstoun Estates legal papers

This collection consists of 36m of records from 1531-1974. The records have been arranged into twenty eight series (see introduction for details) and the finding aid has been separated into these series to make it easier to download from our website.

Part 19 contains legal papers relating to estate of Earlstoun and related lands in stewartry of Kirkcudbright and sheriffdom of Dumfries.
