# Russel & Aitken Papers finding aid (9) Papers of James Wyse, 1698-1874

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Trust of James Wyse.

#### Family history

James Wyse was an Ironmonger and Jeweller in Falkirk. His father, Archibald Wyse was also a merchant in Falkirk. James Wyse was the preses (or chairman) of the Feuars of Falkirk in the 1850s. His heirs included David Wyse, formerly a baker in Dundee.

## Scope & Contents Note

Sederunt book including details of administration of estate, will, inventory of household furniture, minutes of meetings of trustees etc; receipt book for payments made by James Wyse to John Aitken and others; various papers about the executry and beforehand, mostly to do with the ironmongery business and the Wyse family.
