Russel & Aitken Papers finding aid (12) Papers of Heugh family, 1808-1833

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Heugh family who were clients of Russel & Aitken.

Family history

John Heugh of Gartcows is said to have been born at Slammanan in 1745. His sisters were Helen, Alison and Margaret (who married John Stark of Bannyhill). He was related to Thomas Heugh, portioner, of Broomage, Larbert. While he was still young, John Heugh sailed for Calcutta as supercargo and, although shipwrecked, managed to reach his destination where he made a considerable amount of money. He moved to Burma and acted as commissary to the British troops then stationed there. Leaving Burma, he settled in the Cape of Good Hope, following the same line of business. In 1771 he moved to Garbet near Castlecary. In 1786 he acquired the property of Gartcows from Alexander Graham, as heir of his brother, Thomas Graham of Gartcows and farmed there. Later, he acquired additional lands to the south east of Gartcows.

John Heugh of Gartcows was also one of the partners of the Falkirk Bank Company, established in 1787. This existed until the year 1826, when its affairs were wound up, each £100 share yielding £1500 to the partners in return. He took an active part in the maintenance of roads and was a Justice of the Peace in the local courts.

On 20 September 1790 John Heugh of Gartcows married Helen Stark and they had five sons and four daughters. Helen Heugh, the eldest of the family, married Rev. David Scott, M.D., minister of Corstorphine, and afterwards Professor of Hebrew in St Mary's College, St Andrews. Janet Heugh, the second daughter, married George Meek, M.A., of Campfield in 1819. Margaret married James Burn, Writer to the Signet, in 1827, and their daughter, Helen Burn, married William Ellis Gloag, later named Lord Kincairney, one of the Judges of the Court of Session. Mary Heugh married James Aitken, brewer in Falkirk, who afterwards became Provost of the burgh. John Heugh, the eldest son was born in 1792; but died in 1825. Another son was Alexander Heugh who was born in 1800 and died at Dublin in November 1830. William Heugh, the youngest son was born in 1803 and began his career in the Falkirk Bank. His son, another John Heugh lived at Butts House, Houston.

Janet Heugh, who married George Meek of Campfield spent the winter of 1819 in London and then went to Italy. They left Rome to return to Scotland on the 26th July, 1820. However, George Meek contracted malarial fever and died at Hotel of the Tre Mori, at Bologna, as did his wife and newborn child.. The question as to whether the family of the husband or the wife was to benefit by their deaths, led to a close examination of the actual time at which each died, and it was proved that Mrs Meek died half an hour before her husband. George Meek's sisters therefore inherited the estate.[source: Love, James, Vol 1)

John Heugh died in 1822 and was buried in Falkirk Churchyard. his wife Helen Stark died in 1824.
