# Russel & Aitken Papers finding aid (14) Papers of the Duke of Hamilton, 1824-1887

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to work undertaken on behalf of the 10<sup>th</sup> Duke of Hamilton Alexander Hamilton, (1767-1852), the 11<sup>th</sup> Duke of Hamilton, William Alexander Anthony Archibald Hamilton (1811-1863) and the 12<sup>th</sup> Duke of Hamilton, William Alexander Louis Stephen Douglas-Hamilton (1845-1895).

#### Family history

Russel and Aitken acted locally for the Duke of Hamilton roughly from 1827-1890. The dispute about the division of the Reddingrig and Whitesiderig Muirs communities goes back to the feu granted to the Duke of Chatelherault in 1552. There is a reference to an Interlocutor of 1710 but the main references are to the Interlocutor of 1768. The Duke of Hamilton sought to be held as unqualified proprietor of these lands. Large numbers of actions for ejections were served

Papers relating to debt due to Commercial Bank, result of Henry Salmon's activities; connected with Redding Colliery; Papers relating to litigation about the division of the Reddingrig and Whitesiderig Muirs communities including correspondence, minute, court papers, circulars, contracts and accounts.
